





HILOT IPAGBABAWAL NA RIN

INAPRUBAHAN na kamakailan ang isang ordinansa na magbabawal sa panganganak sa loob ng tahanan at pagpapaanak gamit ang tradisyunal na mga "hilot". Ani Councilor Jessica Daza, ang Ordinance No. 2171 ay magtitikay na isasangguni ang mga buntis sa mga lisensyadong health attendants imbes na sa mga tradisyunal na hilot upang mapangalagaan ang kaligtasan ng ina at ang ipinagbubuntis nito laban sa anumang komplikasyon habang hindi pa ito ipinapanganak.

Ipagbabawal din sa mga propesyunal na midwives na magpaanak sa bahay imbes na sa ospital o anumang medical facilities. "We should also take advantage of maximizing the services and facilities of our city health centers to address the medical needs of our constituents, especially from QC's underprivileged communities," sabi ni Bautista. Sinumang mahuhuli ay pagmultahan ng halang P5,000. Samantala, aalukin naman ng livelihood programs ang mga hilot sa QC gaya ng pre at post natal massage classes upang magkaroon sila ng mapagkakataan.

P12 BILYON BUDGET NG QC APRUBADO NA

PINIRMAHAN na kamakailan ang P12 bilyong budget ng Lungsod Quezon para sa 2013 na kalahagan ay gagamitin sa pangkalatang batayang serbisyo, infrastruktura at risk reduction campaign. Ang budget ay mas mataas ng P940 milyon kumpara sa P11,060 bilyon noong 2011. Ilan sa pinakamalaking pagkakastusan ngayong taon ay ang pagpapaunlad ng mga lokal na imprastruktrura, ang

socio-economic program para mabawasan ang kahirapan at pamumuhunan sa kampanya ng risk reduction.

Bahagi ng socio-economic program ang pagdadagdag ng badyet sa edukasyon, kalusugan at disenteng paninirahan para sa mga informal settlers na mawawalan ng kabahayan. Isa ang QC sa pinakamayamang lungsod sa kamaynilaan, sa katanungan, wala itong utang sa pambansang gobyerno at umaabot sa humigit kumulang P10 bilyon ang surplus budget nito sa mga nagdaang taon.



BIRHEN NG LA NAVAL BUMISITA

BINISITA ang Lungsod Quezon ng Our Lady of the Most Holy Rosary ng La Naval para sa ika-73rd Founding Anniversary Celebration ng QC. Noong Oktubre 1973, dineklara ang La Naval bilang patron ng Lungsod Quezon. Ilang religious activity rin ang nailunsad ng Sto Domingo Church katuwang

ang MMDA at ang lokal na gobyerno ng Quezon City.

Inilagak ang imahe ng birhen ng La Naval sa QC Hall mula noong Oktubre 3, at nagkaroon ng misa noong Oktubre 12 bago ito ibinalik sa Sto. Domingo Church. Dumagsa naman 'ang daaan daang deboto noong Oktubre 14, Linggo upang masilayan ang imahe. Nilahukan ito ng iba't ibang kongregasyon, parokya at mga religious school organizations sa QC.

KANLUNGAN NG MGA INABUSO ITATAYO

PINAPLANO ngayon ng lokal na gobyerno ng QC na magkaroon ng kanlungan ang mga inabusong kababaihan, bata, lesbians, gay, bisexuals at transgenders (LGBT). Sinangayunan na kamakailan ng city council ang pagtransforma ng Crisis Center for Battered Women sa loob ng Quezon City General Hospital bilang sentro ng mga naging biktima ng pangaabuso kahit anumang kasarian.

"It is the policy of the State to promote and protect the rights of victims of gender-based violence and abuse," ayon sa ordinansa. "The center shall ensure that the needs of the victims are fully addressed in a gender-responsive and child-friendly manner." Kapag napapatupad, magbibigay ito ng tulong legal, proteksyon, police assistance, medico-legal, psychological services at serbisyon medikal sa mga biktima.

Titiyakin din nito ang kaligtasan at seguridad ng biktima, maliban pa sa matutuluyan na magsisilbing resource center ng mga impormasyon hinggil sa pangaabuso at pandarahas base sa kasarian. Maliban sa pagtatalaga ng mga counselors, maglalagay din ng batikang police officer na hahawak at mangangalaga ng mga kasos hinggil dito.

CASIÑO NAGREKOMENDA NG ALTERNATIBONG MAPAGKAKAKITAAN NG MRT

TALIWAS sa plano na sumpung pisong dagdag na pasaher para sa Metro Rail Transit System, nagrekomenda si Bayan Muna Party-list Representative Teddy Casifio ng mga paraan upang maaitas ang kita nito nang hindi nahihiapan ang bulsa ng mga pasahero.

Nagpaka ng reaksyon si Casifio sa ipinahayag ni Transportation and Communications Secretary Joseph Emilio Abaya na ang ahensya ay itutulak ang planong dagdag pasaher sa MRT sa susunod na taon. Ayon kay Casifio, ang mga mass transit systems tulad ng mga MRT at Light Rail Transit systems (LRTs) ay ginawa upang magbigay ng "cheap transportation services" sa publiko. Kaugnay nito, hinilang niya na ikonsidera ng pamahalaan ang mga sumusunod: Una, pagtatanggal nang hindi nararapat na mga bonus sa mga namamahala at pagtatawa sa onerous loans at mga business arrangements simula noong nakalipas na administrasyon.

Pangalawa, pagdadagdag ng mga tren upang madagdagan din ang kita ng mga pasahero at pagtatayo ng mga pasilidad para sa mga bisikleta upang ma-engganyo silang sumakay sa bisikleta sa mga terminal ng tren. At pangatlo, hikayatin ang mga mall, business establishments at ng local na pamahalaang malapit sa mga ruta ng tren na suportahan ang subsidy fund.

Ayon kay Casifio, tama lamang na patuloy na isubsidiya ng pamahalaan ang MRT sapagka't hindi lamang ang mga kompyuters ang higit na nagbebениpsiyo rito kundi maging ang mga empleyado ng mga pribadong kompanyang malapit sa mga istasyon ng mga MRT.

Naniniwala rin ang Citizens Battle Against Corruption Partylist Representative Sherwin Tugna sa kanyang pahayag na "dapat ay bawasan nila ang kanilang tubo" at "Dapat tandaan na public service ang negosyo ng tren" at ang mga pasahero ng MRT ay hindi dapat nagpapasan ng mga gastos ng tren.

FLOOD PRONE SCHOOLS SA QC TINUKOY

TINUKOY na kamakailan ng Quezon City division of city schools ang 23 paaralang nanganib lumubog tuwing malakas ang ulan at may bagyo. Ayon kay School Division Superintendent Dr. Coronel Rubio, umaabot na sa P3.4 milyong peso ang napipinsala sa mga paaralang nabiktima ng malakas na ulan at bagyo.

Sa report na isinumite ng city engineer department ng kysi, ang mga paaralan na nanganib lumubog ay ang mga sumusunod: Masambong High School, Masambong Elementary School, Sergio Osmeña Sr. High School, North Fairview Elementary School, West Fairview Elementary School, Rodriguez Sr. Elementary School, Carlos Albert High School, Betty Go-Belmonte elementary School, Dr. Josefa Jara Martinez High School, San Bartolome Elementary School, Mines Elementary School, Diosdado Macapagal Elementary School,



Carlos P. Garcia High School, Bagbag Elementary School, Sta. Lucia High School, San Gabriel Elementary School, San Antonio Elementary School, Doña Rosario High School, Doña Rosario Elementary School, Bagong Silangan Elementary School, Bagong Silangan High School at Fairview Elementary School.

Ipinag-utos na ni QC mayor Herbert Bautista ang pag-iinspeksyon sa mga nasabing paaralan upang makita kung gaano kalaki ang

mga pinsala matapos ang sunod sunod na pagbaha noong mga nakalipas na buwan. Pangunungan ni city engineer Joselito Cabungcal ang pagsusuri upang matukoy ang mga posible pang solusyon.

Ani Bautista, pangunahan pa rin ang kaligtasan ng mga mag-aaral. Sa Ulat ni Rubio, ang San Bartolome Elementary School ang may pinakamalubhang kalagayan kung saan apat na classroom ang nasira. Samantala umaabot naman sa P1.59 milyon ang danyos sa Mathay at SB Hall ng Carlos Albert High School.

CAR THEFT CAPITAL HINDI NA QC

INAGAW na ng Maynila sa QC ang bansag na car theft capital matapos ang sunod sunod na nakawan ng sasakyang sa nasabing lungsod ayon sa Highway Patrol Group (HPG) ng Philippine National Police (PNP). Ayon kay Superintendent Edwin Butacan, hepe ng HPG, naungusan na ng Maynila ang QC pagdating sa dami ng insidente ng nakawan ng sasakyang.

Simula noong Pebrero tuloy tuloy ang report hinggil sa mga nawawalang behikulo. Nitong Agosto pa lamang 19 na sasakyang na naiulat na nawawala kumpara sa siyam ng QC. Batay sa report may 50 sasakyang na ang nawawala sa buong Pilipinas. Sa mahabang panahon tinukoy ang QC bilang car theft capital ng Pilipinas, subalit

dahil sa pagpapaigting ng kampaanya ng QC Police District, unti-unting nabawasan ang mga naiulat na kasos. Ang panukala ni dating HPG Director Chief Superintendent Leonardo Espina, na ngayon ay director na ng NCRPO na maglagay ng karagdagang mobile patrol na regular na mag-iikot sa buong syudad ang dahilan kung bakit bumaba ang mga insidente.

Kasabay nito, binanggit din niyang bumaba ang kaso ng nakawan kumpara noong nakaraang taon. Umabot sa 127 sasakyang naitalang nawawala noong Agosto ng nakaraang taon kumpara sa 50 ngayong 2012. Si limampung ito, 26 ang motorsiklo. Ang kadalasan namang target ng mga karnaper ay Mitsubishi Montero, Nissan Urvan, Toyota Vios at Toyota Grandia. Mataas ang tala sa motorsiklo dahil sa maliban sa magaang ito at madaling nakawin, napakahirap ding bawiin pa ang nakaw na mga motorsiklo dahil sa nagkalat na biliran ng 2nd hand spare parts ng motor.

DEMOLISYON IPINATITIGIL

Ipinag-utos ni DILG Secretary Mar Roxas ang agarang suspension sa mga nakatak-dang demolisyon sa mga kabahayan sa Sitio San Roque,

Barangay Pagasa, Quezon City. Ayon sa kalihim, wala pang notice silang matatanggap hinggil sa planong pagpapaalis sa mga informal settlers doon.

Ang tatlumpung eksaryang lupain ay nakatak-dang paularin ng Quezon City Government bilang Quezon City Central Business District katuwang ang National Housing Authority at ang Ayala Land Inc. Ani roxas, kailangang matiyak kung sumunod sa tamang proseso, polisiya at mga kasdunan ang mga ahensya ng gobyerno na may kinalaman sa QCCBD.

Ayon naman kay Kadamay QC Chairperson Cesil Kari, dapat sinserong ipinag-utos ni Roxas ang agarang pagpapatigil ng mga demolisyon



Sa kabilang nito, nakahanda umano silang ipagtanggol at idependa ang kanilang tirahan kung sakaing magbadyang muli ang amba ng demolisyon.

MARALITA WAGI SA AUCTION NG LUPA

NAPAGWAGIAN ng Sta. Maria Della Strada (SMDSC) ng Barangay Pansol sa halagang P700,000 ang 1,200 ektaryang lupain na idinaan sa auction mula ng mag-kaproblema ito sa pagbabayad ng buwis. Ang SMDSC ay ang organisasyon/kooperatiba ng mga maralita na tinutulungan ng lokal na parokya.

Unang hakbang palang anila ito sa tagumpay ayon sa mga lider ng SMDSC at Pangkat Ugnayan sa Paninirahan PUSP homeowner's association na siyang nanguna sa laban upang matiyak ang paninirahan nila sa 3.3 ektaryang lupain na inookupa ng mga maralitang lungsod ng may halos 50 taon na.

"Bihira ang tagumpay na kagaya nito sa mga gaya naming urban

poor na kailangan pang magnakaawa, lumuhang at lumaban bago mapasaya ng tuluyan ang lupa. Masaya kami, na kami ang nagwagi sa bidding", ayon sa SMDSC chairman Norberto Nazareno.

Daan-daang residente naman mula sa Kaingin 2 ang sumugod sa harap ng LandBank malapit sa City Hall upang magbigay ng suporta sa mga kasamang nasa loob ng auction. Ayon naman kay Jose Evilla, tumaas ang presyo sa aktwal na bidding dahil malamang di nila alam na may nakatirik na mga informal settlers doon. Pero nakatutuwang aniyang sila ang nagwagi. Sakaling malipat sa SMDSC ang lupain, ipamamahagi ito sa 30 pamilya na magbabayad ng P25,000 sa loob ng 20 taon na may 1 porsyentong interes.

PROPOSED BILLS

HOUSE BILL 2308: "CHILD NUTRITION LAW OF 2010"

An act providing for a mandatory nationwide child nutrition program in all public elementary schools and Barangay Day Care centers.

This includes the participation of every agency of the national and local government and its objective is to ensure adequate health and nutrition programs that are accessible to young children. That these children are prepared for formal learning, and to establish an efficient system for early identification and prevention for developmental disorders and disabilities in early childhood.

HOUSE BILL 3413: ANTI - POLITICAL DYNASTY ACT OF 2010

An act prohibiting the establishment of political dynasties.

The policy of the state to guarantee equal access and opportunity to public office and service to the public.

This act encompasses the consolidation of public office and political power by person to one another, which includes the family of incumbent official or a relative within the second civil degree of affinity.

STAND ON CYBERCRIME LAW or the "CYBERCRIME PREVENTION ACT OF 2012"

October 8, 2012 Team Teddy wrote "Just in time for the Supreme Court en banc session tomorrow Makabayan senatorial bet Teddy Casiño together with the Philippine Internet Freedom Association (PIFA) filed the 14th petition against Cybercrime law at the Supreme Court. The progressive solon filed the petition on his capacity as a blogger and a regular internet user."

61 page petition was filed by Casiño with the representatives of PIFA asking for a Status Quo Ante Order and/or a writ of Preliminary Injunction be issued against the respondents, commanding respondents to cease and revoke the implementation of the Cybercrime Prevention Act of 2012.

USS GEORGE WASHINGTON THE UNITED STATES BATTLESHIP AND AIRCRAFT CARRIER; THE EMPIRE STRIKES BACK

The US Navy's *Nimitz* class forward - deployed aircraft carrier USS George Washington (CVN 73) arrived in Manila Bay last October 24, on a good will visit, the visit is aimed at enhancing ties between the two allied countries through community relations projects and exchanges between troops.

The USS George Washington was the fourth of its kind to enter in the Philippine territorial water this year. Anchored several kilometers away from Pasay City, Manila. Amid the long territorial dispute with China in the West Philippine Sea.

The Philippines had reach out to the United States for help in training and modernizing the country's forces, the urge to strengthen its military defense while the country is still engaging into a diplomatic negotiation with China.

Captain G.J. Fenton, George Washington's commanding officer, told The Associated Press USS George Washington's visit to the Philippines shows that our 61-year-old mutual defense treaty is still alive" on board the hulking warship anchored at Manila Bay. "It shows that the United States is committed to the Filipino people, and we actively support a reliable partner and a strong ally," he said. "We have a longstanding history of partnership with the Philippines dating back to the Spanish-American war and we are always appreciative of the opportunity to be able to work with one of our regional partners," he added.

The USS George Washington a nuclear-powered aircraft carrier, with two nuclear reactors that permit the ship to steam for almost 18 years before refueling. Built by the Newport News Shipbuilding Company, December 27, 1982. Commissioned on July 4, 1992, 216 years after America declared its independence from the British, in Norfolk, Virginia.

After 10 years of planning, building and testing the warship. The aircraft carrier was the fourth ship to bear the name after George Washington, one of the founding fathers and the first President of the United States. The nuclear-powered super carrier has its homeport in Yokosuka, Japan.

George Washington and its embarked air wing, Carrier Air Wing 5, has the capability for combat-ready force to protect and defend the collective maritime interests of the United States, its allies and partners in the Pacific. It has a missile launcher that can be used against attacking aircraft and anti-ship missiles in any weather.

With a cruise speed of 30 knots (equivalent to 55.5 kilometer/hour) USS George Washington can travel more than 500 kilometers a day and a flight deck length of 1,092 feet from keel to mast, with a width of 275 feet and a height of 244 feet that could embark about 75 numbers of aircraft. Built with two anchors each weighing about 30 tons.



The aircraft carrier has around 5,500 sailors serving on board and can even accommodate up to more than 6,200 people which is served with 18,000 daily meals. About 800 of the carrier's fleet force were either born in the Philippines or are of Filipino descent. It has a fresh water distilling plants with a daily capacity of around 400,000 gallons, enough to supply 2,000 homes and weighs 60,000 tons of structural steel.

AKBAYAN facing DISQUALIFICATION

Two petitions for disqualification of Akbayan Citizens Party from 2013 election were filed last October. Anakbayan, National Union of Students in the Philippines, and League of Filipino Students filed the first disqualification against Akbayan. Anakbayan Chairperson Vencer Crisostomo said in an interview that Akbayan is no longer marginalized or underrepresented. In the disqualification case filed by Anakbayan they cited that Akbayan is a privileged party in power because their members are currently in influential positions in the Aquino administration. Secondly, nominees from Akbayan don't come from the sectors they are supposedly representing. Lastly, Akbayan is a party supported by the government. They use government funds to campaign for their party. Eighty-one (81) consultants of the NAPC are officials and members of Akbayan.

The Bagong Alyansang Makabayan (BAYAN) supports the disqualification petition against Akbayan to run in the 2013 elections. "This is unfair and undue for the truly marginalized" Renato Reyes said Bagong Alyansang Makabayan Secretary General.

Akbayan Truly Representing Marginalized sector?

Akbayan representative Walden Bello said in an interview that disqualification cases filed against them are just because of jealousy about what Akbayan had reached for the benefits of the marginal. "They don't like Akbayan because of our reform orientation that basically benefits the masses. We're making their thunder as an organization that's successfully bringing progressive politics into the mainstream," he added. "Akbayan tried to divert the attention of the people with the major argument that Akbayan's officials and members are in high positions under the present administration." Crisostomo said.

In February 2010, former Akbayan Representative Etta Rosales sent a statement to the media stating the disqualification of "pro-administration" socialist during Gloria Macapagal Arroyo's presidency. She also stated that these partylist were "palace-backed", "Palace fronts" and "puppets disguised in marginalized party-list robes". "How is Akbayan different from these government-backed pseudo party-list groups?" Crisostomo added.

They cited the case of Ang Bagong Bayani in 2001, where Supreme Court said that the party-list system as stated in the Constitution: "social justice was designed not only to give more law to the great masses of our people who have less in life, but to also enable them to become veritable lawmakers themselves, empowered to participate directly in the enactment of laws designed to benefit them. It intends to make the marginalized and the underrepresented not merely passive recipients of the State's benevolence, but active participants in the mainstream of representative democracy".

Akbayan nominees and members currently occupy high positions in the government. These are as follows:

1. Renato Reyes, former AKBAYAN president, is the Presidential Political Affairs Adviser of President Aquino;
2. Joe Rocamora, former AKBAYAN president and ideologue, is currently the Chairperson of National Anti-Poverty Commission, and appointee of President Aquino;
3. Loretta Ann Rosales, former AKBAYAN president and representative, is currently the Chairperson of the Commission on Human Rights, and appointee of President Aquino;
4. Maria Agno, former AKBAYAN representative, is currently a member of the GSIS Board of Trustees;
5. Herminio Gendana, former AKBAYAN chairperson, is currently the National Youth Commission commissioner-at-large, appointee of President Aquino;
6. Dennis Suliman, chairperson of the AKBAYAN's Alliance of Progressive Labor, is now a Commissioner of the Social Service System;
7. Berna R. Gutierrez III, Akbayan's 2nd nominee for the 2013 elections is Undersecretary for Political Affairs;
8. Angelina Ladonice Katib, Akbayan's 3rd nominee is a Commissioner in the Presidential commission for the Urban Poor,
9. Blas Bustos-Burauel, Akbayan president and representative, is Spokesperson of the National Anti-Poverty Commission.

"The appointments in high government offices proved that Akbayan is now well-entrenched in government and well-connected to the appointment which means that they are not marginalized" the complaint said.



THE BANGSAMORO FRAMEWORK AGREEMENT

(Beginning of the Long and Lasting Peace in Mindanao)

October 16, 2012 the formal signing of Framework Agreement between Moro Islamic Liberation Front and Philippine Government happened in Malacanang. This was after the 32nd Exploratory Talks took place in Kuala Lumpur, Malaysia. The two parties agreed on the final draft of the agreement for the establishment of the new political entity to be called Bangsamoro. To many Filipinos it was a beginning of peaceful relationship between Christians and Muslims.

GRP- MILF peace negotiation

MILF is a religious political organization made up of Muslims engaged in liberation struggle in their traditional homeland embracing Mindanao, its adjacent island and the Sulu. MILF wants a long and lasting peace and self-determination.

MILF has engaged itself in peace negotiations with the GRP since 2001. When President Estrada was ousted with a people power Former Vice President and President now congressional representative Gloria Macapagal Arroyo took the position.

During Arroyo's administration, the GRP- MILF Peace Negotiation has gone through a Memorandum of Agreement on Ancestral Domain. The Supreme Court juked the MOA in October 14, 2008, which "guarantee" constitutional amendments that is beyond the power of the president. The said MoA should have established the Bangsamoro Juridical entity. This failure of MOA-AD made the factions between MILF, which established the Bangsamoro Islamic freedom Fighters.



GPH-MILF peace negotiation: Pnoy administration

It is when the Aquino administration that it change the name of the GRP to GPH. The peace panel was headed by the GPH Head Peace negotiator Marvic Leonen and the MILF Mo-hagher Iqbal. The Aquino administration takes a success in peace negotiation when the Framework Agreement of the Bangsamoro has been signed.

In the speech of Aquino during the signing of the Agreement, he said, "No longer the MILF aspire of a separate state. This means that the hand once held rifles will be put to use tilling land, selling produce, manning work stations, and

opening doorways of opportunity for other citizens." The president added that the Bangsamoro will follow the constitutional process ensure the Philippines remains one nation and one people.

One provision of the Bangsamoro Agreement was the establishment of the Bangsamoro which according to Murad Ebrahim, MILF Chair need constitutional amendments.

Marvic Leonen also said, that the transition commission can only make recommendations, but it is up to Congress to dispose constitutional change."

According to National Democratic Front Consultant Luis Jalandoni that a constitutional amendment is a clear requirement, which make the Bangsamoro dependent on constitutional and legal process of the GPH.

Before the agreement, the MILF wanted to became a substate, self-determination for their ancestral domain.

"Much work still has to be done to make peace work. The forging of the Framework Agreement does not mean the end of the struggle for it [only] ushers in a new and more challenging stage," Murad Ebrahim MILF Chair.



On October 6, 2012, AFP gave a statement that they have captured the high ranking official of the Communist Party of the Philippines "Benjamin Mendoza" alias Rolly Panesa.

Rolly Panesa, 48 years old, a security guard of Megaforce Security was arrested last October 5 of the 2nd Infantry Division of Philippines Army, which was led by Southern Commander Maj. Gen Alan Luga and the Philippine National Police. Panesa accused of being a high-ranking official of the Communist Party of the Philippines known as "Benjamin Mendoza" which has a bounty of P5.6M.

Wife of Rolly Panesa, Marites Chioco said that they are in their way home in Project 4, Quezon City with her daughter Connie Rey Garcia and husband Peter Que, when men approached them and forced them to ride in a car.

"They insisted that I'm Ka Luisa and Rolly my husband is Benjamin Mendoza a high ranking official of the Communist Party of the Philippines. I told them that I'm Marites Chioco from San Jose, Nueva Ecija and my husband is Rolly Panesa not Benjamin Mendoza". Chioco said

The next day, Chioco was shocked when she saw the face of her husband bloated and have broken lips. In a medical examination made by the PNP Region 4 and Health Action for Human Rights they diagnosed Panesa to have sustained scratches and bruises. Both doctors said that he has to consult an ear specialist because of the damage in his right ear.

Panesa detained in SICA-BJMP at Camp Bagong Diwa, Taguig faces a rebellion charge together with two other National Democratic Front of the Philippines consultants Tirso "Ka Bart" Alcantara and Allan Jazmines. He was also accused of frustrated murder.

Mistaken Identity

According to Rey Cortez from National Union of Lawyers in the Philippines, lawyer of Panesa he wants to emphasize that the AFP arrested the wrong person "Rolly Panesa is not Benjamin Mendoza".

" AFP can easily identify the identity of Rolly Panesa. The day when they arrested him, Panesa had his IDs issued by different government agencies that will prove that he is not Benjamin Mendoza; he had with him his Social Security Service ID, driver's license and the security guard ID that was issued by the Philippine National Police. "Cortez said.

Cortez said that a call of the arrested team would confirm that Panesa is a guard in Megaforce Security since 1995. Obviously, they did not do it. They just want to say that they have captured Benjamin Mendoza," Cortez added.

Benjamin Mendoza according to the Armed Forces of the Philippines is a member of the Central Committee of the Communist Party. They added that Mendoza was a known active member of Samahan ng Demokratikong Kabataan in 1975 and studied explosive making in Libya in 1982. Two warrants of arrest are issued to Mendoza in Lucena City Court.

KARAPATAN is requesting for the immediate release of Rolly Panesa. They said that evidences would prove that Panesa is not Mendoza. They said that Panesa is from Negros Occidental not in La Union where Mendoza was from. KARAPATAN also added that during 1975, Panesa was 11 years old, and studying at Macabalong Elementary School and in 1982 he was studying in High School.

There are evidences that Panesa was tortured during his interrogation. Chioco said that her husband told her that in the car where he was riding he was already tortured by the arresting team.

"Torture and illegal detention was not new in this regime. KARAPATAN have document 70 victims of torture and 447 illegally arrested from July 2010 to September 2012. We condemn the torture to Panesa , it is a clear violation of Anti- Torture Act and Republic Act No. 7438 that state the right of the arrested person. Anyone, even rebel should not be torture" karapatan said.

MRT FAIR HIKE TO BE IMPLEMENTED NEXT YEAR

On October the Metro Rail Transit (MRT) alerted the public that it will soon impose a fare hike. DOTC Sec. Abaya at a press conference said that the fare hike should be implemented next year to decrease the budget allocated by the government and instead give to the countryside. DOTC even reasons that the proposed MRT fare hike is lower compared to the bus fare which is about Php 45.

Different sectors are opposing the proposed fare increase. RILES Network led the petition signing campaign in different MRT and LRT station to get signatures from MRT commuters and others who are against the increase.

History

MRT has 13 stations, from North Edsa to Taft Ave. In 1990's MRTC and DOTC made an agreement to establish MRT in a Build-Operate-Transfer (BOT) scheme. In the said agreement, the MRTC, which is a private company, will take care of the construction and maintenance of the MRT while the DOTC will have to pay them monthly to reimburse the expenses of MRTC in building the said project.

In September 1997 when the construction of the MRT began after the signing of contract between Mitsubishi Heavy Industries, Sumitomo Corporation and local company EEI Corporation entered as sub-contractor of the said project.

In 1999 MRT first opened to the public transportation from North Edsa to Buendia; after a year, it added the route from Buendia to Taft Avenue. In 2004 the average number of passengers riding the MRT reached to 400,000, daily.

Burden

Leon Peralta co-convenor of RILES Network and Vice Chairperson of MAKABAYAN QC said, "MRT fare hike means passing on the responsibility of the government to provide public service. Public transportation is a public service and should be subsidized." He added, "Passengers riding MRT are basically from lower class that earn P426 a day or has less than P10,000 monthly income. It is an added burden for it will lessen our budget which should be allocated to food for the family."

Riles said that the Operation and maintenance of MRT is lower compared to the present fare that the passengers are paying. Only P9.11 per passenger is needed to operate and maintain the MRT. "MRT customers are paying P0.89 to P5.89 more than what it is needed to maintain its operation. We from Riles call for lower fare in MRT" RILES added.

The government said that the budget for the MRT reached P75Billion in ten years for its Operation and Maintenance.

"MRT is a public transportation service, the government should not pass the burden to its commuters. It is clear that behind this fare increase is privatization under the program of Aquino administration's public private partnership."

According to IBON foundation, the DOTC spent Php 8.52 billion for the MRT, of which almost Php 5.30 billion went to the guaranteed profits of the private contractors proponents; Php 1.18 billion for maintenance costs; Php 1.16 billion debt payments; and the remaining Php 880 million for other expenses. But actual revenues in 2010 was only Php 1.92 billion, of which Php 1.90 billion came from passenger and the rest from non-rail revenues such as from advertisements, rent of commercial space etc. thus, the DOTC is short of Php 6.60 billion which the government finances through additional borrowing (or so called subsidies). But without the guaranteed profits and debt payments- which make up 76% of DOTC's MRT obligations in 2010, fares could cover the cost of maintenance and personnel expenses.

RED ALERT ON CHILD POVERTY

CHILD welfare group, Akap Bata Party-List kicked off the celebration of the National Children's Month last October 2012 in a media forum in Quezon City. In the said event, the group raised social alarm against the worsening state of child poverty in the country under the present administration of President Benigno Simeon Aquino III.

Brosas also declared the 'Nationwide Red Alert Day' on October 17, in time of the International Day for the Eradication of Poverty. On this day, a nationally-coordinated noise barrage will be held in various points all over the country to further amplify the rising alarm against child poverty.

Finally, in time of the first day of filing of politicians for their Certificate of Candidacy for the 2013 midterm elections today, Akap Bata Party-List urges all political aspirants to heed the alarm against child poverty and have clear agenda and program of governance for the Filipino children.

Ayon sa Committee to Protect Journalist ito ang pinakamalalang kaganapan sa kasaysayan ng mga journalist. Talumpu't apat sa walumpung biktima ay mula sa hanay ng mga mamamahayag. Maliban sa bilang ng pinaslang mas nakakagulat na ginawa ang krimen sa gitna nang tirik na araw sa isang highway at ang katotohan na ang pinalibingan ng mga biktima ay ginawa dalawang araw bago ang krimen at ang mga gumawa ng krimen ay hindi man lang itinago ang kanilang pagkakilinan.

Ano ang nagbigay ng lakas ng loob sa pamilya Ampatuan na gumawa ng ganitong klaseng krimen?

Ang pamilya Ampatuan ang isa sa pinakamakapangyarihan na angkan sa Mindanao at siya pinakamakapangyarihan sa probinsya ng Maguindanao. Sa kabilang matinding kahirapan nananatili ang mga mansion ng pamilya Ampatuan. Mayroon silang 2000 private army na sinasabi ng sa Philippine Army at mga pulis nanggaling ang mga armas. Sinasabi rin na ang pamilya Ampatuan ang nagtiyak ng pagkapanalo ni dating Pangulo Gloria Macapagal Arroyo noong 2004 presidential election sa pamamagitan ng pagmanipula sa eleksyon ng probinsya. Ang kalayaan ng pamilya Ampatuan at ang kontrol nila sa probinsya ang pangunahing argument sa pananatili ng political dynasties.



– Wikipedia



Demokrasya at Participatory Governance

Sa darating na Mayo a-diyes, dadagsa muli sa mga presinto ang masang taumbayan. Gagamitin ang kanilang karapatang bumoto. Sa mass media, muli nating maririnig sa mga komentarista na ang pagboto ay ebidensya ng pag-iral ng demokrasya sa bansa. Totoo ba ito?

Right to Vote = Demokrasya?

Sinasabing umiiral daw ang demokrasya kapag ang taumbayan ay pumipili ng mga lider ng gobyerno sa pamamagitan ng kanilang pagboto.

Hindi na raw kasi ito tulad ng sinaunang mga gobyerno na naghahariang isang pamilyang dugong bughaw sa bisang “divine right” na binabasbasan ng simbahang relihiyon. Gaya ng Pilipinas na nooy pinagharian ng mga Kastila (o sa mas eksakto, tayo ay kolonyang hari’t reynang Espanya).

Bumalik na daw kasi ang sinasabing “demokrasya”. Napabagsak na ang diktadurang Marcos noong 1986. At isa raw sa mga “biyaya ng Edsa” ang panunumbalik ng karapatang bumoto.

Pero ano nga bang totoong ibig sabihin ng demokrasya? Sa simpleng salita, ito ay “rule of the majority”. Ibig sabihin, nag hahariang kapasyahan ng mayorya sa lipunan. At ang nakararami sa lipunan ay walang iba kundi ang manggagawa, magbubukid, estudyante, propesyunal at maliliit na manininda, atbp. Ganito ba ang kalakaran? Hindi.

Sapagkat ang naghahari pa rin sa bansa ay ang mga kapitalista’t asendero. At ang nanumbalik lamang sa sinasabing “restorasyon ng demokrasya” ay ang klaseng pulitika bago mag Martial Law. Ito ang sistemang elitistang demokrasya.

Ang Sistemang Elitistang Demokrasya

Ayon sa 1987 Constitution, ang umiiral daw sa bansa ay isang “representative democracy”. Tama. Ang taumbayan ay naghahalal ng kanilang kinatawan o representante sa gobyerno. Pero hindi sapat ang pagboto bilang palatandaan ng demokrasya.

Sapagkat ang importante ay hindi lamang ang “boto” at “buwis” kundi ang “boses” ng nakararami na dapat salaminin ng mga batas at patakaran ng pamahalaan.

Sa umiiral na sistemang demokrasya sa bansa, “hindi kasali” ang taumbayan sa pagtatakdang batas at patakaran ng gobyerno. Hindi man lang kinukonsulta ang kanilang “boses”. Ang kanilang tanging papel ay pumili ng representante sa isang araw sa loob ng tatlo o anim na taon. Matapos ang eleksyon, sila ay bumabalik sa pagiging mga sibilyang taga sunod lamang sa utos at dikta ng mga nasakapangyarihan.

Ang nagaganap ay kabaliktaran ng demokrasya. Patay na letra ang Konstitusyunal na probisyon na ang lahat ng kapangyarihan at awtoridad ay nag-mumula sa taumbayan. Ayon sa saligang batas, “Sovereignty resides in the people. All power and authority emanates from them.”

Malayung-malayo ito sa praktika ng mga samahan ng masang may pagkilala sa kapangyarihan ng kanyang kasapihan (katulad ng unyon). Kung saan, umiiral ang 3Bs ng demokrasya: ang boto, butaw at boses.

Sa unyon, ang kasapihan ay naghahalal ng liderato o executive board (boto). Bilang kasapi, sila ay may tungkuling magbigay ng butaw o “union dues” gaya ng pagbabayad ng buwis ng mamamayan bilang bahaging kanyang tungkulin sa gobyerno’t lipunan (butaw/buwis). At sa anumang hakbangin o planong unyon, kinokonsulta ang boses ng myembro. Naglulunsad sila ng “general membership meeting” para marinig ang pasyang karamihan (boses).


Pero hindi ganito sa lipunan at gobyerno. Sa unyon, bawat pisong idadagdag sa butaw (dues) ay dumadaan pa nga samatinding deliberasyon ng kasapihan. Sa gobyerno, tumataas ang VAT at iba pang kaltas sa sahog ng mga employado pero hindi naman sila nakokonsulta ukol rito!

Participatory Governance: Gawing Bahagi Ang Mamamayan sa Paggugubyerno

Ang papel ng mamamayan sa pulitikang bansa ay higit pa sa simpleng pagboto para sa kanilang kinatawan kung totoong umiiral ang demokrasya. Kailangan ng kanilang partisipasyon sa pagbabalangkas at pagpapatupad ng batas.

Kaya ang ating sinusulong: ang “participatory governance”. Upang maiimpluwensyan ng ordinaryong tao ang mga desisyon ng gobyerno kahit sila ay nananatiling sibilyan at hindi bahaging burukrasya. Ito rin ang diwa ng itinayong Naga People’s Council ng yumaong kalihim ng DILG, si Secretary Jesse Robredo.

Sa kasaysayan ng maraming bansa – laluna sa Europa – ang paglahok sa pulitika ng milyon-milyong mamamay ang sibilyan ay sa pamamagitan ng “partido-pulitikal”. Kung saan, sumasapi o nagiging aktibo ang isang ordinaryong tao sa anumang partido, na sa kanyang pagtingin, ay nagtatanggol ng kanyang interes o prinsipyo. Halimbawa, labor party para sa manggagawa; greens party para sa environmentalist, women’s party sa kababaihan, atbp.



Sa ating bansa, hindi ganito ang mga mainstream na partido. Sapagkat ang kasapi nila ay hindi naman ang simpleng mamamayan kundi ang mga pulitiko – laluna ang mga mula sa LGUs (local government units), mga governor, mayor, konsehal, atbp – na humahakot ng boto para sa kanila tuwing eleksyon. ‘Di kasali ang taumbayan liban sa pagiging audience (gaya ng sa telenobela) sa kanilang mga pamiting at mga asemblya.

Mas importante kasi sa mamamayan, kung tutuusin, na maghanapbhay kaysa sa mag-aksaya ng panahon sa pulitika. Kung gayon, kailang ang suhayang ito mismo ng gobeyerno. Maglaan ng pondo’t rekursong partisipasyon ng masa sa paggubyerno, ito ay kung tunay na ang sinunod nito ang mga konstitusyunal na probisyon ukol sa “kapangyarihan ng taumbayan”.

Maaring may magsabi ng hindi marunong sa paggubyerno ang taumbayan – laluna ang nakararaming mahihirap. Subalit ibinunga lamang itong kalagayang ang kanilang paglahok sa halalan ay tuwing eleksyon lamang bilang botante ang kanilang partisipasyon sa pulitika.

Isang halimbawa ng maaring anyo nito ay ang “people’s council”, kung saan regular na tinitipon ang mga halal na kinatawan ng mga samahan ng masa (unyon, TODA, asosasyon ng maralita, organisasyon ng maliit na manininda, atbp.) mula sa antas ng barangay, distrito hanggang sa lungsod o lalawigan.

“Manalig sa mamamayan!” Bigyan sila ng oportunidad na lumahok sa pagbabalangkas at pagpapatupad ng batas. Hayaan natin silang maranasan ang paggubyerno. Sapagkat, sa huling pagsusuri, ang demokrasya ay hindi lamang natututunan sa libro kundi sa buhay at praktikal na karanasan. At ang kakulangan sa kaalaman ng mamamayan ukol sa paggubyerno ang isa sa dahilan (at isa rin sa mga paraan) kung paano sila napagsasamantahanan ng iilang elitistang may monopoly sa kapangyarihan.

In commemoration of the 149th birth anniversary of The Great Plebeian Andres Bonifacio, another biopic that will either oblique or explicitly suggested that Andres Bonifacio more deserved to be considered the first Philippine president than Emilio Aguinaldo and national hero than Dr. Jose Rizal. It's Richard Somes' "Supremo."

Supremo is set in old Manila circa 1800s, the movie hunted down the reason why Andres' blaze to fight for freedom against the Spanish regime; how the KKK (Kataas-taasan, Kagalang-galangang Katipunan ng mga Anak ng Bayan) was formed; and even about the treachery he suffered in the hands of his own "Katipunero" brothers.

Unlike his role in the late Mario O'Hara's "Ang Paglilitis Kay Andres Bonifacio," actor-politician Alfred Vargas, was quite challenged with this "passion-of-the-christ" like epic. But, thanks to his glowing adulation for the hero, Vargas rose to the test and delivered a most evocative performance of the most controversial and famous Katipunero to date.

With numerous biopics done in honor of Bonifacio, "Supremo" depicts the subject as person; more human, overly patriotic war hero. That despite his great love for the country, he has had his moments of outbursts, weaknesses and doubts.

All these were showcased in sepia toned frames, underscored by breathtaking dusk and silhouette scenes set against vast meadows and rice paddies, which the old Manila was best known for.

The film was shot in just 15 days; "Supremo's" production team sure took the time to make the best of what they have. From the hefty props and costumes of the actors, to the apt locations, and the vivid fight scenes down to the music used for the scoring, everything spelled class and creativity rolled into one.

But with students as the film's obvious target audience, perhaps it would be wise for "Supremo" to be cut shorter than its original two-and-a-half-hour run. Additionally the movie needs some polishing on its transition sequences. Most of the abrupt scene changes, tend to be confusing in that one isn't sure if Andres was having flashbacks or if he was in present time.

Alfred did justice to Andres' controversial yet courageous life. But it was theater actor Nicco Manalo, the son of comedian Jose Manalo, who was a revelation in the film as he breathed so much vigor into the character of young soldier Emilio Jacinto. Unfortunately though, Macario Sakay's (Mon Confiado) character was overshadowed by the two, probably because he wasn't given much lines or maybe even because his wig was in disarray the entire time.

His opponent is former old 2nd district Representatives Annie Rosa Susan (of the United Nationalist Alliance) and Dante Liban. Vargas, a Makabayan Party member, also declared that he is willing to sacrifice his showbiz career for the sake of his family and constituents.

Cybercrime Law

The Supreme Court ordered to suspend the implementation of the Cybercrime Prevention Act or the Republic Act No. 10175 dated Oct. 9. The court issued the order because of 15 different petition filed against the said law. "Now, therefore, effective immediately and for a period of 120 days, you, your agents, representatives or persons acting in your place or stead are hereby enjoined from implementing and/or enforcing Republic Act No. 10175 or the Cybercrime Prevention Act of 2012!"

The Cybercrime Prevention Act provides implementation of law in a cyberspace. "From all forms of misuse, abuse, and illegal access by making use of such conduct or conducts. In this light, the State shall adopt sufficient powers to effectively prevent and combat such offenses by providing arrangements for fast and reliable investigation, and prosecution at both the domestic and international levels, and by providing arrangements for fast and reliable

Implementation of the Cybercrime Prevention Act has been suspended due to 15 petitions mainly internet users, lawyers, media and progressive organizations. According to Philippine Internet Freedom Foundation, a group of different organization of netizens and bloggers, the cybercrime law is undemocratic and has negative implications on the right to freedom of expression. "The cybercrime law is testing our country—whether we're truly a democracy or just a democracy on paper" Red Tani President of Pifia.

The main issue in the law was the issue of libel. Libel according to Revised Penal Code Article 352 "public and malicious imputation of a real or imaginary, or any act, omission, condition, status or circumstance tending to discredit or cause the dishonor or shame of another person, or to blacken the memory of one who is dead."

According to a lawyer from the Philippines, anyone who posted any libelous comments is liable for "internet libel" which has 12 years imprisonment. According to the International Commission of the Philippines lawyer, slammed the government for criminalizing the libel in internet even United Nation also pointed out that the Revised Penal Code is "incompatible" in Philippine context.

Two members of Congress, Senator Teddy Casiño and Raymond Palatino filed a petition to repeal some of the provisions in the law. According to Casiño of Bayan Muna, the main issue in the said law was from Section 6 which provide that offenses under the Revised Penal Code and special laws, such as libel, communication and communication technologies, would have penalty of one degree higher than the code provided.

"The penalty one degree higher than what had been stated in the RPC on libel, longer prison terms are guaranteed for persons found to be guilty of posting or containing libelous remarks online," Casiño added.

According to the NPC, the provisions being questioned:

"Libel, not only on the internet, but also on "any other similar means which may be devised in the future;"

"Any person who attempt, aids or abet the commission of a cyber offense;

"Any person who commits any offense through the use of information and communication technologies, would have penalty one degree higher the penalties provided for by the Revised Penal Code for all crimes committed through and with the use of information and communication technologies."

According to the NPC, apart from prosecution under the law, any person charged for the alleged offense covered will not be spared from violations of other special laws;

Section 5 (b)

"Enforcement authorities, including the submissions of "timely and regular reports including pre-operation, post-operation and other documents as may be required to the DoJ;"

"Real-time collection of traffic data;

"Authorities to collect or record, by technical or electronic means, traffic data in real-time;

"Authorities to search, seize and examine computer data;

"Provides and law enforcement agencies to "completely destroy the computer data subject of a preservation and examination."

According to the NPC, the DoJ is block access to computer data when such data "is prima facie found to be in violation of the provisions of this Act;" and "any person who fail to comply with provisions of Chapter IV (Enforcement and Implementation), specifically orders from law enforcement and prison correctional (6 months and 1 day to 6 years) in its maximum period or a fine of P100,000 or both, for each

Violation of Regional Trial Courts (RTC) and designated cybercrime courts over violations of any of the provisions of the law; and cooperation from all relevant international instruments, international arrangements, and domestic laws in the implementation of the law.

The Cybercrime Prevention Act is a violation of the right for due process, right to privacy, freedom of expression etc. Supreme Court also calls for the suspension of the law on January 15.

Green Group

Wants charges filed against US military contractor for toxic waste dumping in Subic Arrest and prosecute owners and officers of the irresponsible, arrogant Glenn Defense Marina Asia!



“We strongly condemn the irresponsible dumping of hazardous and toxic waste in Subic Bay by US Navy contractor Glenn Defense Marine Asia. The owners and operators of tanker MT Glenn Guardian deliberately and recklessly dumped their toxic waste to our waters. This shows not only their disregard to the integrity of our environment and the health of our people but also affront to our national sovereignty,” said Clemente Bautista of the militant environmental group Kalikasan People’s Network for the Environment (Kalikasan PNE).

The SBMA has accused operators of MT Glenn Guardian of intentionally dumping tons of toxic wastes to the waters of Subic Bay. The SBMA has previously conducted laboratory testing and has proven that the tanker is carrying hazardous and toxic materials. However, the tanker owner asserts their right under the US-RP Visiting Forces Agreement (VFA) that the company and its operation in Philippine territory is not covered by Philippine laws thus cannot be held accountable by the Philippine government and its agencies.

“The case of Glenn Defense Marine Asia is a clear example of how the so-called visits of US military warships endanger us all. It is as if Subic Bay, and the whole of the country is once again in a large military base where the US military can have their ships travel and operate wherever they want.

“The US left toxic wastes in Clark and Subic when they left in 1991. They have not yet cleaned this up and is now again party causing another toxic contamination on our shores.”

“President Aquino should order the urgent filing of a criminal case, the arrest of officers and officials of MT Glenn Guardian, and confiscate their assets in the Philippines. After requiring them to pay their liabilities, authorities should immediately expel Glenn Defense Marine Asia and its vessels and bar them from further operating in the Philippines,” Bautista said.

Based on the website information of Glenn Defense, retired and former Chief of Philippine Navy Mateo Mayuga is one of the top rank officials of company and heads its operation here in the Philippines. Glenn Defense is regularly servicing the US Naval forces. In 2007 and 2009, Glenn Defense vessels operated in the Philippines when it serviced military ships USS Blue Ridge and USS George Washington CSG, respectively.

“This incident proves that the military exercises and activities under the VFA worsens not only social problems such as violence against women and prostitution but also grave environmental crimes. It is high time that the government should abrogate and junk the VFA,” Bautista said.

Ang demolisyon ay naganap kahit walang "notice of eviction" o kautusan mula sa korte. Ang lupang kinatirikan ng mga kabahayan sa BIR ay pag-aari ng gobyerno. Aminado ang demolition team na hindi nila binigyan ng babala ang mga residente upang hindi makapaghanda. Ang BIR ay bahagi ng lupang tatayuan ng Quezon City Central Business District(QC CBD).

Quezon City Urban Poor Summit

"Walang ibang patutunguhan ang maralitang lungsod. Kahit saan ay may demolition, sa lungsod man o sa probinsya. Saan na lang pupunta ang maralita?" Carlito Badion convenor ng Alyansa Kontra Demolisyong.

Pagkatapos ng madaliang pagdemolish sa BIR road, nagkaroon ng summit ang mga maralitang lungsod sa Quezon City noong Oktubre 20, 2012 sa Claret College Seminary na may temang "Maralita ng Lungsod Quezon: San ka Pupunta? Pagtitipon Laban sa Zero Informal Settler Program ng QC". Dinaluhan ng iba't ibang barangay at organisasyon sa Quezon City ang sunnit. Ayon sa AKD, ang pinakamalaking proyekto ng lokal na gobyerno ng QC ay ang pagtatayo ng Central Business District na magwawalis sa libong maralitang lungsod.

Ang Quezon City Central Business District (QC-CBD) ay magdudulot ng dislokasyon sa maraming komunidad ng maralitang lungsod at mga ahensya ng gobyerno na malapit sa Elliptical road.

Ayon sa tala ng lokal na pamahalaan ng Quezon City, mayroong 234,104 pamilya ay bahagi ng tinatagaw na informal settlers na nakatira sa mahigit 188,390 kabahayan. Sa QC may 26,974 pamilya ang nakatira sa mga danger zone ang planong alisin. Ito ang mga erya o barangay na malapit sa creek, Tulahan River, Pasig River Rehab Program Area, transmission lines, MWSS Pipelines, ilalim ng tulay, Sidewalks, at dumpsites (tambakan). Kasama rin sa mga aalisin erya ng QC- CBD, West at South Triangle at ang Damayang Lagi dahil sa mataas na halaga, turismo at investment.

Pabahay sa Bansa

Ayon sa United Nation, umabot sa 23.9 milyon ang informal settlers sa lungsod ng Pilipinas noong 2007. Nangangahulugan ito na kalahati ng populasyon ng nasa syudad ay bimbuho ng mga taong nakatira sa nasabing mga lugar. Dagdag ng United Nation ang mga urban poor na lugar ay ma-categorized ayon sa 1. Kakulangan sa pagkakaroon ng malinis na tubig 2. Kakulangan sa pagkakaroon ng maayos na sanitasyon at imparastruktura. 3. Mababang kalidad ng gamit sa paggawa ng bahay 4. Siksikan ang kabahayan at populasyon 5. Walang katiyakan sa paninirahan.

Ayon sa Urban Poor Resource Center of the Philippines, isang institusyon na naglalayong paglingkuran ang Pilipinong maralitang lungsod. "ang problema sa pabahay ay isang larawan lamang ng kahirapan. Ang mga "squatter" na komunidad na nagsusulutan ay isang paalala sa atin nang pagkakaroon ng hindi pagkakapantay-pantay."

Ayon sa gobyerno may 1.4 pamilya ang nabiblang sa informal settlers. Ang Housing and Development Coordinating Council (HUDCC) ay binigyang kahulugan ang informal settlers bilang: a. Lupang tinitirhan ng walang pahintulot ng may ari b. danger zones c. Lugar na tatayuan ng gobyerno ng proyekto d. protected/ forest area(maliban sa mga indigenous people) e. eryang prioridad para sa kaunlaran, f. lupa ng gobyerno at pampublikong pasilidad na hindi para sa mga kabahayan.

Ayon mismo kay Vice President Jejomar Binay kailangan ng P252 bilyon para sa isang disenteng pabahay pero naglaan lamang ng P7 bilyong budget ngayong taon.

Disenteng Paninirahan

Idineklara sa pandaigdigang karapatang pantao na karapatan ninuman ang disenteng tahanan.

"Pero ano ang ginagawa ng gobyerno ni Aquino? Sa halip na bigyan ng disenteng pabahay ang mamamayan niya, inaalisan pa sila ng bahay at tinatapon na parang basura sa lugar na walang kabuhayan. Katulad na lang ng sa Kasiglahan na isang relocation site na binibigay ng gobyerno," sabi Badion

Binaha ang Kasiglahan noong panahon ng Habagat noong nakaraang September. Ang Kasiglahan ay relokasyong binigay ng gobyerno sa mga malis na maralita sa Metro Manila.

Dagdag pa ni Badion na kahit ang mga nagparelocate mula sa San Roque ay bumabalik sa kanilang dating mga tahanan dahil maliban sa malayo sa kanilang trabaho o kabuhayan, hindi rin matino ang mga pasilidad sa mga relocation site.

Ayon sa report, may 4,999 pamilya ang apektado ng demolisyon o tangkang demolisyon sa ilalim ng panunungkulan ni President Aquino noong 2011 lamang.

PUBLIC HEALTH in DANGER

Ensuring provision of health services is a priority if the nation is to be considered healthy. It is a right that every person must enjoy. This should be reflected in the state of health of its people.

This year, the budget for health service is P 46.76 billion. In the 2013 budget, while DOH is allocated PhP 5.6 billion, bigger compared to last year's budget, it only represents 1.89% of the national budget versus the 5% ration to GDP (gross domestic product) set by the World Health Organization.

According to health groups, the government is passing on its responsibility to the private groups to improve facilities and services of public hospitals as a scheme towards privatization and corporatization.

Privatization and Corporatization: Inaccessible Health Service.

In House Bill 6069 filed by Representative Roilo Golez, 26 public hospitals are subject to corporatization including the Philippine Orthopedic Center. Philippine Orthopedic Center is a public hospital that will undergo the first Public-Private Partnership program of the Aquino Administration.

The cost of modernization of the Philippine Orthopedic Center is at

PhP 135.5 million. This includes additional 700 beds for orthopedic patients. The private sector will finance, build, operate, and maintain the facilities for 25 years. According to the government, this will provide the comprehensive services for the treatment and prevention of bone / joint diseases.

According to Alliance of Health Workers (AHW), corporatized hospitals are not accessible and affordable for the poor patients. The National Kidney and Transplant Institute's test for blood sugar is more expensive compared to Capitol Medical Center. Even at the Lung Center of the Philippines, the use of equipment and machines are not free.

Six out of ten Filipino are dying because of lack of medical attention. Due to the high cost of hospitalization, poor Filipinos would not run to a hospital even if they are seriously ill. According to Health Alliance for Democracy, health service is very expensive for the poor even in public hospitals.

In 2011, health budget was cut by P 1.4 billion (from 38.6 billion), reducing allocation for public hospital and indigent's subsidies. The reduction in budget results to inadequate facilities and an increase of fees to get medical

attention. In 2011 alone, 400, mostly children, have died from diseases that can be treated.


The Philippine General Hospital, charges fees for the basic examinations. Only 12 out of 192 basic examinations are free which include: CBC with differential count, Hematocrit or Hct, platelet count; routine manual urinalysis; routine fecalalysis; FBs or fasting blood sugar, Na, K, Cl, Creatinine; chest x-ray (post anterior or AP) or any two plate examinations and ECG or electrocardiogram. X-ray services, which used to be free, will now have corresponding fees.

The Philippine General Hospital is a good example of privatization. It is a clear evidence that the government is passing on its responsibility to provide health service to private sectors, AHW added.

URGED TO RELEASE STUDY ON MINIMUM WAGE VIOLATORS



A labor NGO has urged Labor Secretary Rosalinda Baldoz to release the department's report on companies which do not comply with the minimum wage, as it also criticized the new salary system for private sector workers that condones such violations.

The Ecumenical Institute for Labor Education and Research (Eiler) said DOLE cites the existence of "millions of vulnerable workers" who are unprotected by the minimum wage as the main basis for implementing the Two-Tiered Wage System, yet has failed to present a study backing up this claim.

"In the interest of transparency, Labor Secretary Baldoz should release the full results of DOLE's inspection regarding compliance with the minimum wage law. Otherwise, she is only confirming workers' suspicion that the new wage system is just the result of the government agency's collusion with big business," Eiler executive director Anna Leah Escresa said.

"Failure to release such report only traps workers in underpayment of wages and condones the greed of various firms in the country," she added, citing a study showing that some 15 percent of surveyed companies in the Philippines are violating the minimum wage law as per DOLE press release.

Eiler noted that in August 2010, DOLE promised to identify firms which do not comply with the mandated minimum wage.

Escresa explained that on top of the firms' non-compliance, the labor department has unfortunately rolled out the Two-Tiered Wage System (2TWS) that actually condones rampant underpayment of wages in the country.

"By setting a floor wage that is way lower than the mandated minimum wage, DOLE through the 2TWS is letting greedy violators off the hook. Suddenly, the criminal deeds of companies becomes legalized," Escresa said.

The labor think-tank cited the case of Region IV-A, where the P337 minimum wage is cut by 25 percent to P255 as the new floor wage.

"Apart from clearing greedy companies from underpayment of wages, the 2TWS directly imposes a cut on workers' wages and pulls down bargaining capacities of unionized workers. Companies will definitely use the lower wage standards to shortchange unions," Escresa emphasized. "This anti-worker wage scheme must be immediately junked"



BLESSED CALUNGSOD

On October 21, 2012 Pedro Calungsod was canonized as among Catholic saint. Calungsod was the second Filipino saint after Lorenzo Ruiz. Many Filipinos all over the world awaited his canonization.

Pope Benedict XVI said "Pedro displayed deep faith and charity, and continued to catechize his many converts, giving witness to Christ by a life of purity and dedication to the Gospel. Uppermost was his desire to win souls for Christ, and made him resolute in accepting martyrdom."

As former Pope John Paul II said in Calungsod beatification last 2000, the youth should not be hesitant to follow the example of Calungsod. Even many Filipinos believe that he should be the model of the youth nowadays.

LIFE OF CALUNGSOD

According to documents, very few know about Pedro Calungsod. He was a boy who came with Spanish Jesuits to evangelize Chamorros in 1668 somewhere in North Pacific Ocean. Fr. Diego Luis de San Vitores led the mission. One of the tasks of the volunteer is to bring the things that the father will use in his mass and baptisms. It said that San Vitores chose Calungsod as his "faithful companion" in his missions. Thirteen thousand natives were converted doctrine in their mission.

In 1672, rumors were spread by Choco, a Chinese merchant in order to malign the missionaries told the natives that the water that they use is poisonous. Incidentally, many babies died and because natives believe in superstitions, healers supported that the cause of the death is the water of the missionaries.

Many Chamorros lost belief in God and blamed the missionaries for what happened to them. It was said in the documents that Matapang and Hirao killed San Vitores and Calungsod. Matapang was a converted Catholic who rejected his belief after hearing the rumors about the missionaries.

Calungsod died beside the San Vitores. Some documents said that their bodies thrown in the water.

MIRACLES

One of the bases of canonization is a miracle. Catholics believe that a true miracle is the one that science cannot explain. Pedro Calungsod made a major miracle on March 23, 2003 in Cebu City. A 49-year old woman was dying because of lack of oxygen in her brain. According to the doctor, the patient supposed to die anytime but the woman, who prayed to Blessed Calungsod, miraculously was brought to life.

In 2011, Pope Benedict XVI declared that it was a miracle made by Calungsod.

Taong 1940 nang unang tumira si Nanay Mameng sa Leverista. Hindi nila pag-aari ang lupang kinatitirikan ng kanilang bahay. Noong siya ay nagka-asawa at anak, pangunahing pinagkukunanan ng kamilang kita ay ang pagtanggap ng labada ni Nanay Mameng. Nakaranas ng pananakit si Nanay Mameng sa kamyang asawa. Halos lahat ng mga malapit sa kanya ay sinabihan niya ng kanyang problema. Katulad nang sinabi niya sa kamyang ina ang pang-aabuso na ginagawa sa kanya: sinabihan lang siya nito na bumangon kung saan siya natumba. At dahil relihiyoso si Nanay Mameng, kahit ang mga kasama niya sa simbahang siyag labag sa kalooban ng Diyos ang pakikipaghiwalay na pinaplane niya. Kahit ang mga pulis ay sinabihan siyang hindi sila nakikialam sa usapin ng mag-asawa.

Hindi siya nagkaroon nang lakas ng loob na makikipaghiwalay sa kamyang asawa; hanggang sa naging kasapi siya ng Samahan ng Maralitang Kababaihang Nagkakaisa (SAMAKANA). Noon nya nataramdam ang halaga ng pagiging babae at pagdedesiyo ng tpusin ang karahasang nararanasan niya.

Buhay at Pakikibaka

Tatlong dekada na ang nakalipas nang maging kasapi si Nanay Mameng ng Kabataan para sa Demokrasya at Nasyonalismo (KADENA) noong 1978. Limampung taong gulang siya noon. Siya ang natatanging miyembro ng KADENA na may edad na. Ang KADENA ay isang organisasyon ng kabataan noong panahon ni Pangulong Marcos. Makalipas ang ilang taon naging kasapi si Nanay Mameng ng Samahan ng Maralitang Kababaihang Nagkakaisa (SAMAKANA) at naging presidente siya nito sa loob ng labing-isang taon.

Siya ang kauna-unahang president ng Kalipunan ng Damayang Mahihirap noong panahong itinatag ito noong 1998. Naging pangatlong nominee siya ng Anakpawis. Bagaman hindi nakaupo sa Kongreso ipinagpatuloy ni Nanay Mameng ang pakikipaglaban para sa karapatatan at kapakinabangan ng maralitang lungsod.

Nakilala si Nanay Mameng noong People Power 2 o EDSA Dos na nagpatalisk kay Estrada. Nakilala siya bilang isang matandang babae na hindi nagpapaawat sa pagsasalita. Sa mahabang panahon nang kanyang pakikibaka, makailang ulit na ring nalakad ni Nanay Mameng ang kalsada papuntang Mendiola.

Sa tuwing magsasalita si Nanay Mameng sa mga pagkilos, halos lahat ng mga tao ay lumalapit sa stage at hindi pinapalampsang pagkakataon na mapakinggan siya nang malapitan. Hindi mabilang ang mga palakpak sa tuwing siya ay aakyat at bababa sa entablado. Nakilala si Nanay Mameng sa kanyang mga quotable quotes na tumatagos sa puso at nag-iwan ng marka sa utak sa sino mang makakarinig. Isa sa sikat niyang quote ay ang pagbansag niya kay dating Pangulong Gloria Macapagal Arroyo na " Gloria- Makapali- ang - Mukha".

" Hindi sapat ang mga salita para ilarawan si Nanay Mameng. Siya ay matapang at walang inuriungan. Bagaman may edad na, nananatili pa rin siyang matalas sa pagsusuri sa kalagayan at mga isyu ng mamayaman. Siya ang tunay na boses ng maralita." Sabi ni Gloria Arellano Vice President ng KADAMAY.

Kahit hindi nakapagtapos, hindi mapagkakaila ang kadakilaang nagawa niya bilang isang kritiko ng nakaraang administrasyon.

Sining Kadamay in cooperation with Urban Poor resources center launched the first ever film festival which caters the interest of the urban poor and their struggles. The said film festival was held last September 27- 29 at the University of the Philippines Diliman College of Mass Communications Auditorium, Plaridel Hall. Teachers, students, and supporters of urban poor attended it.

ORGANIZER: Sining- KADAMAY

Sining Kadamay is a cultural organization under the KAdamay National that was founded in 1998. Sining KAdamay believes that a nationalist, scientific and mass- oriented culture should be the alternative in a colonial, feudal culture that the Philippine society had. "We believe that art is a powerful arm in promoting the interest and rights of the people and welfare of the urban poor. Because of poverty, talents and skills from the urban poor sectors have not developed".

Sining Kadamay explores all forms art to propagate its advocacy. Sining Kadamay sings, dance, act, exhibits photos and paintings and videos.

"Cinemaralita is a great breakthrough activity of our organization. Actually, it is our first time to have film festival." they added.

CINEMARALITA Film Festival

Cinemaralita as its name implies is a Film Festival, which includes short films, and full-length film that discusses the condition of the urban poor in the country. It targets all universities in Metro Manila to inform the students and people about the reality of life of the urban poor.

The film festival is an income generating project to sustain Sining Kadamay's activity for its advocacy.

"If there is Cinemalaya for the independent film makers, we also have Cinemaralita which presents the conditions of the urban poor." Sining Kadamay said

The Cinemaralita's launching in University of the Philippines was successful. Sining Kadamay presented different films and movies in different time slots and dates:



Almost every film caters to the interest and the lives of the urban poor in the cities. Barikada of Tudla Production is about the life of a mother and an activist sprotecting her house together with other neighbors in San Juan. The film emphasizes the struggle of the urban poor in everyday life and the importance of collective action in fighting for their rights. The film is based on the actual struggle of people in San Juan had to face threats of demolition. While Mula Third Ave. Hanggang Dulo discusses the changes happening to a young man when he joined the comprehensive youth organization. The documentary was taken in 3rd Ave, area in Caloocan City where there are lots of "gangster and tribes". The story is about the daily routine of the youth in 3rd Ave. Maynila sa Kuko ng Liwanag was a film of National Artist for Screenplay Lino Brocka which was taken from the book sa " Kuko ng Liwanag" by Edgardo Reyes . It was about a Julio a fisherman who traveled to Manila to look for his wife, Ligaya. Julio experienced unjust relation with his employer when he became a construction worker. It purely reflects the life of a Filipino urban poor who comes from the province and experiences the wild world of Manila, the real stories behind the propaganda of beautiful life in the city.

After the movies, an open forum is held for the discussions, questions, and suggestions from the audience to further improve the said activity. Tickets range from P50 to P 80 for students. Special tickets for patron are also available which is from P500 to P1000. Sales from the tickets will allocate in paying the venue and technical of the project.

Cinemaralita will run from September to December 2012 in different schools in line with the commemoration of the Human Rights day. On third week of November Cinemaralita' will be at De La Salle University.


