AN ORDINANCE MANDATING THE PUBLICATION AND DISTRIBUTION OF THE QUEZON CITY BUSINESS DIRECTORY WHEREIN ALL REGISTERED BUSINESSES AND RESPECTIVE ENTITIES, ADDRESSES, PHONE NUMBERS, E-MAILS OR WEBSITE, FACSIMILES AND THE LIKES ARE LISTED FOR THE GENERAL PUBLIC NFORMATION.

WHEREAS, Ordinance No. SP-1429, S-2004 has created the Quezon City Business Registry Databank;

WHEREAS, the Quezon City Business Registry Databank has its objectives (1) to improve the City government's business information data; (2) to rationalize business zoning; and (3) to keep track of business developments;

WHEREAS, one way to achieve the objectives in putting up the Quezon City Business Registry Databank is to formulate and print a business directory which can be made available to all business owners and the public in general.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Quezon City Council hereby mandates the formulation and printing of a business directory for Quezon City.

SECTION 2. The Quezon City Business Directory shall be distributed by the office of the City Mayor thru the Business Permits and Licensing Office (BPLO) at a cost not more than Two Hundred Pesos (P200.00) for the current and subscribing year 2007, to all the business entities registered therein."

SECTION 3. The Quezon City Business Directory shall have its annual calendar identification and revisions by the concerned agency, the Business Permit and Licensing Office (BPLO).

SECTION 4. This Ordinance shall take effect immediately upon its approval.
