A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH 8990 HOUSING DEVELOPMENT CORPORATION, REPRESENTED BY ITS CHIEF EXECUTIVE OFFICER, ATTY. ANTHONY VINCENT S. SOTTO, FOR THE ACQUISITION OF URBAN DECA HOMES COMMONWEALTH, A HIGH-RISE PROJECT, LOCATED IN LITEX, BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY, AS A SOCIALIZED AND AFFORDABLE HOUSING PROJECT OF THE CITY

WHEREAS, the Quezon City Local Government, through the Housing, Community Development and Resettlement Department (HCDRD), is mandated to implement Republic Act No. 7279 or the "Urban Development and Housing Act of 1992" and Ordinance No. SP-2771, S-2018 or the "Quezon City Comprehensive Socialized Housing Code of 2018" and to provide decent and affordable housing to underprivileged and homeless citizens;

WHEREAS, 8990 Housing Development Corporation is the developer of Urban Deca Homes Commonwealth, a high-rise project consisting of 4 buildings with 13 floors and 3,144 units, including 373 car parking slots located in Litex, Barangay Commonwealth, District II, Quezon City;

WHEREAS, pursuant to the Quezon City Local Government and 8990's commitment to contribute to the community and promote the mandate of the housing sector, 8990 agrees to convey more or less 3,144 units of the Project to the Quezon City Local Government, who shall in turn convey the same to the latter's qualified beneficiaries;

WHEREAS, the Quezon City Local Government shall utilize the Project for the benefit of the homeless, underprivileged, and Informal Settler Families, as well as government employees in Quezon City, all subject to be screened and pre-qualified by a Beneficiary Selection Committee;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign and execute a Memorandum of Agreement with 8990 Housing Development Corporation, represented by its Chief Executive Officer, Atty. Anthony Vincent S. Sotto, for the acquisition of Urban Deca Homes Commonwealth, a high-rise project, located in Litex, Barangay Commonwealth, District II, Quezon City, as a socialized and affordable housing Project of the City.
