AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF MADRINAN VILLAS (3-STOREY TOWNHOUSES WITH 12 UNITS), CONTAINING AN AREA OF ONE THOUSAND THREE HUNDRED EIGHTY-TWO SQUARE METERS AND FORTY SQUARE DECIMETERS (1,382.40 SQ.M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-15205 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SPOUSES FRANKLIN A. EVARISTO AND MARIELIESE SALDANA EVARISTO, AND LOCATED AT LOT 10, BLOCK S-12, DILIMAN ESTATE SUBDIVISION, PSD-7365-B, NO. 27 SCOUT MADRINAN STREET, BARANGAY SOUTH TRIANGLE, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY MARIELIESE SALDANA EVARISTO, CO-OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Madrinan Villas (3-Storey Townhouses with 12 units), containing an area of One Thousand Three Hundred Eighty-Two square meters and Forty square decimeters (1,382.40 sq.m.) covered by Transfer Certificate of Title No. RT-15205 of the Registry of Deeds of Quezon City, registered in the name of spouses Franklin A. Evaristo and Marieliese Saldana Evaristo, and located at Lot 10, Block S-12, Diliman Estate Subdivision, Psd-7365-B, No. 27 Scout Madrinan Street, Barangay South Triangle, Quezon City, Metro Manila, as applied for by Marieliese Saldana Evaristo, co-owner, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93, PD 957 and to the pertinent provisions of Quezon City Resolution No. SP-808, S-97.
