ORDINANCE NO. SP-390, S-96

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF RESIDENTIAL SUBDIVISION (CMP), SITUATED AT NO. 224 STO. DOMINGO STREET, BARANGAY BALINGASA, QUEZON CITY, AS APPLIED FOR BY SAN ANTONIO DE PADUA HOMEOWNER'S ASSOCIATION, INCORPORATED, REPRESENTED BY GREGORIO B. LACE, SUBJECT TO COMPLIANCE WITH THE CONDITIONS PRESCRIBED UNDER CRDINANCE NO. SP-56, S-93, BP 220 AND PD 1096, AS AMENDED.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASEMBLED:
